No more than three hundred and forty (340) Game Prizes will be awarded for any reason. If, due to a technical, production, human or other error, more than three hundred and forty (340) entrants receive a winning Notification, the three hundred and forty (340) intended Game Prizes will be awarded in a random drawing from among all recipients of such Notifications.

The total ARV of all Game Prizes is \$3,980.
